Old Business

• <u>Finalizing Amended ADCO By-Laws</u>— Alex Fajardo reviewed the amended ADCO by-laws. Discussion of the document took place. Rivera suggested on page 8 that the words, "at the pleasure of the member", be added to: [(x) Member-Appointed Directors shall serve, "at the pleasure of the Member", terms of one year,]

Coyne presented a motion to accept the amended by-laws as presented, with the additional verbiage suggested by Rivera. Rivera seconded the motion and the motion to approve the amended by-laws with the additional verbiage was approved by unanimous vote of the Board.

<u>Finance Committee Report (FOC)</u> as reported by Greg Panchisin (Business Manager)

Greg reviewed the May monthly financial report. Actual to budget remains favorable. Several questions were raised and answered. Greg commented that the construction of Phase III is continuing as scheduled. He presented a spreadsheet of overall costs of the project to date. Actual to budget remains favorable. Several questions were raised and answered. Change orders have been kelp to a minimum.

<u>Head of School Report</u> as reported by Margie Lopez-Waite (Head of School)

Enrollment

- Goal for 2015-2016 = 628 (100% of goal)
- As of 6/25/15, we have 632 (101% of goal) enrolled.
- Goal is 641 (102%)
- We are in the process of filling remaining spots from wait list.

Team Update

- Attrition from 2014-2015 to 2015-2016 = 12 (19%)
- Termination: 5 (8%)
- Resignation to pursue higher education: 2 (3%)
- Resignation due to personal: 5 (8%)
- Exit interviews revealed the following:
- Of those who resigned, they reported having a positive experience at LAAA and would consider returning without exception.
- Team Recruitment
- All positions have been filled for the 2015-2016 school year (see attached organizational chart)

Grant Update

- Longwood Foundation awarded \$750K (ask was \$1.5M)
- Welfare Foundation no award (ask was \$600K)
- Wels Fargo no award (ask was \$95K)
- Arsht-Cannon awarded \$15K (ask was \$15K)
- Performance Fund submitted June 2015; potential award is \$250K; decision expected by end of July

Graduation Update

- 25 students graduated on June 5, 2015
- Commencement Speaker State Representative Joe Miro
- Ceremony held at DE School for the Deaf
